DEFINITIONS & INTERPRETATION

Definitions: The terms defined below are important terms which apply under this Policy. These terms are used with initial capitals in the Policy Document and shall have the meaning ascribed to them below wherever they appear in the Policy Document:

- 1) **“Age”** means age as on last birthday which is the number of completed years on the last birthday.
- 2) **“Annual Cash Bonus”** means bonus, if declared, as specified in Part C of this Policy Document.
- 3) **“Annualized Premium”** shall be the premium amount payable in a year excluding taxes, rider premiums, underwriting extra premiums and loadings for modal premiums,
- 4) **“Appointee”** means the person named in the Schedule to whom the Death Benefit shall become payable if the Nominee is less than Age 18 when the Death Benefit becomes payable.
- 5) **“Assignee”** is the person to whom the rights and benefits are transferred by virtue of an Assignment, in accordance with the provisions of Section 38 of Insurance Act, 1938, as amended from time to time.
- 6) **“Assignment”** is the process of transferring the rights and benefits to an Assignee, in accordance with the provisions of Section 38 of Insurance Act, 1938, as amended from time to time.
- 7) **“Claimant”** means Nominee/ Appointee (if Nominee is a minor) / Assignee / Your legal heirs (where there is no Nominee/Appointee / Assignee).
- 8) **“Date of Commencement of Risk ”** means the date specified in the Schedule on which the risk under this Policy commences.
- 9) **“Death Benefit”** means the benefit which becomes payable on the Life Assured’s death in accordance with Part C of this Policy.
- 10) **“Distance Marketing Mode”** means insurance solicitation/lead generation by way of telephone calling/Short Messaging Service (SMS)/other electronic modes such as e-mail, internet and interactive television (DTH)/direct mail/newspaper and magazine inserts or any other means of communication other than in person.
- 11) **“Endorsement”** means a written confirmation issued by Us on the Schedule to record any changes to the applicable terms and conditions of this Policy or the details contained in the Schedule. Endorsements shall form a part of this Policy and shall be binding on You and Us. It is agreed that the terms of an Endorsement shall supersede any conflicting provisions in this Policy Document, Rider or Schedule.
- 12) **“Financial Year”** means the twelve month period between 1st April of each calendar year and 31st March of next calendar year.

- 13) **“Fully Paid-Up Policy”** means a Policy on which due Instalment Premiums for the entire Premium Payment Term has been received in full by Us.
- 14) **“Grace Period”** means the time granted by the insurer from the due date of payment of premium, without any penalty or late fee, during which time the policy is considered to be in-force with the risk cover without any interruption, as per the terms & conditions of the policy. The grace period for payment of the premium for all types of life insurance policies shall be fifteen days, where the policyholder pays the premium on a monthly basis and 30 days in all other cases.
- 15) **“In-force”** means a policy in which all the due premiums have been paid and the premiums are not outstanding.
- 16) **“Instalment Premium”** means the premium amount specified in the Schedule which is payable under this Policy at the frequency specified in the Schedule.
- 17) **“Insured Event”** means the death of the Life Assured during the Policy Term while Policy is In-force.
- 18) **“IRDAI”** means the Insurance Regulatory and Development Authority of India.
- 19) **“Lapse”** means the status of the Policy where due Instalment Premium, for the period as specified in the Part D of the Policy, have not been paid within the Grace Period and where Policy benefits, if any, shall become payable in accordance with Part D.
- 20) **“Life Assured”** means the person named in the Schedule on whose life the insurance cover under this Policy has been granted.
- 21) **“Maturity Benefit”** means the benefits which become payable on or after the Maturity Date any additional and accrued benefit, which is payable on maturity in accordance with Part C of this Policy. Part C will specify whether a Maturity Benefit is payable under this Policy.
- 22) **“Maturity Date”** means the date specified in the Schedule on which the Maturity Benefit (if any) becomes payable if the conditions specified in Part C of this Policy are satisfied.
- 23) **“Nominee”** means the person named in the Schedule who has been nominated by You, to whom the Death Benefit shall become payable if the conditions specified in Part C of this Policy are satisfied. Any change of Nominee shall be in accordance with Section 39 of The Insurance Act, 1938 as amended from time to time.
- 24) **“Nomination”** is the process of nominating a person(s) in accordance with provisions of Section 39 of the Insurance Act, 1938 as amended from time to time.
- 25) **“Policy”** means the contract of insurance entered into between the Policyholder and Us as evidenced by the “Policy Document”

- 26) **“Policy Document”** means this Policy Document, the Proposal Form, the Schedule and any additional information or documentation provided to Us in relation to the Proposal Form, any Endorsements issued by Us and any Riders attached to this Policy.
- 27) **“Policyholder”** means the person named in the Schedule on whom the contract under this Policy is executed and owns this Policy and, subject to the terms and conditions of this Policy, holds all the rights under the Policy.
- 28) **“Policy Anniversary”** means the same date as the Policy Commencement Date in each Policy Year during the Policy Term.
- 29) **“Policy Commencement Date”** means the date specified in the Schedule on which this Policy commenced.
- 30) **“Policy Term”** means the period specified in the Schedule which is the number of years from the Policy Commencement Date to the Maturity Date.
- 31) **“Policy Year”** means a period of 12 consecutive months reckoned from the Policy Commencement Date and every subsequent Policy Anniversary, thereafter.
- 32) **“Premium Payment Term”** means the period in years as specified in the Schedule during which the Instalment Premiums are payable.
- 33) **“Premium Due Date”** means date specified in the Schedule on which the Instalment Premium will become due.
- 34) **“Proposal Form”** means a form to be filled in by You in utmost good faith, in written or electronic or any other format as provided by Us, for furnishing all material information as required by Us in respect of a risk, in order to enable Us to take informed decision in the context of underwriting the risk, and in the event of acceptance of the risk, to determine the rates, advantages, terms and conditions of the cover to be granted under this Policy.
- 35) **“Reduced Paid-up Policy”** means a Policy on which due Instalment Premiums are not received after a specified number of Instalment Premiums have been received. Part D of this Policy will specify whether and under which conditions this Policy may be considered to be a Reduced Paid-up Policy. If this Policy is converted to a Reduced Paid-up Policy, then only those reduced benefits specified in Part D of this Policy will be payable on the occurrence of the insured events.
- 36) **“Revival”** means restoring the Lapsed or a Reduced Paid-up Policy to an inforce Policy as per the revival conditions mentioned in Part D of the Policy.
- 37) **“Revival Period”** means the period of five consecutive complete years from the date of first unpaid premium in accordance with the terms of Part D of this Policy.

PART B

- 38) “**Schedule**” means the Policy schedule given in Part A of the Policy which is issued by Us and attached to this Policy together with any amendments to the Schedule or Endorsements which may be issued by Us from time to time.
- 39) “**Sum Assured**” means the amount specified in the Schedule.
- 40) “**Sum Assured on Death**” means an absolute amount of benefit which is guaranteed to become payable on death of the life assured in accordance with the terms and conditions of the policy.
- 41) “**Sum Assured on Maturity**” means an absolute amount of benefit which is guaranteed to become payable at the end of the policy term i.e. on maturity of the policy in accordance with the terms and conditions of the policy..
- 42) “**Surrender**” means the complete withdrawal/termination of the entire Policy. Part D of this Policy will specify whether and under which conditions this Policy can be surrendered.
- 43) “**Surrender Value**” means an amount, if any, that becomes payable on surrender of a policy during its term, in accordance with the terms and conditions of the policy. Part D of this Policy will specify the manner of calculation of the Surrender Value, if any.
- 44) “**Survival Benefit**” means the benefit payable during the Policy Term, as specified in Part C, subject to survival of the Life Assured as on due date of such benefit.
- 45) “**Terminal Bonus**” means bonus, if declared, payable in accordance with Part C of this Policy, if any, which may be paid on the death of the Life Assured during the Policy Term or upon the maturity of the Policy.
- 46) “**Total Premiums Paid** ” means total of all the premiums paid under the base product , excluding any extra premium, and taxes, if collected explicitly.
- 47) “**Vesting Date**” means the Policy Anniversary coinciding with or immediately following the Life Assured attaining Age 18, if the Life Assured was a minor on the Date of Commencement of Risk. Part F of this Policy will specify whether and under which conditions this Policy will vest with the Life Assured.
- 48) “**We, Us, Our, Company**” means Future Generali India Life Insurance Company Limited.
- 49) “**You, Your**” means the Policyholder of this Policy as named in the Schedule.

PART B**Interpretation:**

- 1) References in this Policy to the singular shall include the plural and vice versa.
- 2) References in this Policy to one gender shall include the other gender.
- 3) References in this Policy to any statutes, rules, regulations or guidelines shall include any re-enactments or amendments to the same.
- 4) Section/paragraph headings are for ease of reference only and shall not have any interpretative value.
- 5) Words and expressions used in this Policy but not defined herein shall, unless the context specifies otherwise, have the same meaning as defined in the Insurance Act 1938 and/or the rules/regulations/guidelines made thereunder as may be amended from time to time.

PART C

POLICY BENEFITS & PREMIUM PAYMENT CONDITIONS

This Policy is an Individual, Non-Linked, Participating (with profits), Savings Life Insurance Plan which provides benefit on Death, Survival and Maturity.

Amendments to this Policy shall be effective only if such amendments are carried out through Endorsements issued by Us.

1) Commencement of Risk Cover under this Policy

The risk cover under this Policy shall commence only on the Date of Commencement of Risk, including in case of a Life Assured who is a minor.

2) Death Benefit

a) If the Life Assured dies on or after the Risk Commencement Date but during the Policy Term and provided that the Policy has not lapsed, surrendered, or been converted into a Reduced Paid-Up Policy in accordance with the provisions of Part D, then the Death Benefit payable shall be as follows:

For both, Plan Option 1: Immediate Income and Plan Option 2: Deferred Income

Death Benefit payable shall be highest of the following:

- i. 105% of Total Premiums Paid (excluding the applicable taxes, rider premiums and underwriting extra premiums, if collected explicitly) as on date of death or
- ii. Sum Assured on Death plus Terminal Bonus, if declared.

Where Sum Assured on Death is defined as 10 times the Annualized Premium (excluding the applicable taxes, rider premiums and underwriting extra premiums, if any) as specified in the Schedule.

- b) Payment of any Death Benefit under Clause 2 (a) is subject to deduction of any outstanding dues from You under this Policy including but not limited to due premiums till the date of the death of the Life Assured, outstanding Policy loan, loan interest or any other dues and applicable taxes, if any, and the same is subject to the exclusions described under the Policy.
- c) The Policy will terminate on payment of the Death Benefit.

PART C

3) Participation in Profits and Bonus

- a) This Policy, if not Lapsed or not been converted into a Reduced Paid-up Policy in accordance with the provisions of this Part D below, shall participate in the profits of the Company's Participating Life Assurance Policyholders' Fund from the Policy Commencement Date during the Policy Term. The Policy gets a share of the profits emerging from the Company's Participating Life Assurance Policyholders' Fund in the form of bonuses, if declared.
- b) Annual Cash Bonuses if declared, are declared as a percentage rate, which apply to the Sum Assured. They are declared annually at the end of each Financial Year and shall be applicable till next bonus declaration date based on the statutory valuation carried out under prevailing regulations.
- c) The Annual Cash Bonuses, if declared, shall be determined separately for each Plan Option where the Plan Option chosen is specified in the Schedule. Annual Cash Bonus Rates may vary by Policy Year under both Plan Options.
- d) Once declared, they form a part of the guaranteed benefits of the Policy.
- e) Contingent Future Annual Cash Bonus rate may be declared every Financial Year and will explicitly accrue only when a Fully Paid-Up Policy is surrendered.
- f) Terminal Bonus, if declared, may be paid on the death of the Life Assured or on the Maturity of the Policy.

4) Survival Benefit

If the Life Assured is alive and that the Policy has not been cancelled, surrendered, lapsed or been converted into a Reduced Paid-up Policy in accordance with the provisions of Part D below, Survival Benefit as specified below shall be paid to You on the Survival Benefit payment dates as specified in the Schedule under 3(i).

Survival Benefits are paid based on the Plan Option chosen as specified in the Schedule provided all due Premiums till the date of the Survival Benefit are paid and upon survival of the Life Assured on the Survival Benefit payment due dates.

a) Plan Option 1: Immediate Income

The Survival Benefits are payable in arrears and shall be equal to sum of:

- i) Guaranteed Income, as a percentage of Sum Assured per annum as described in Table 1 below, payable from the first Policy Year till the end of the 25th Policy Year

And

ii) Annual Cash Bonus, if declared, as a percentage of Sum Assured, payable from the first Policy Year till the end of the Policy Term. The amount of bonus will depend upon the Sum Assured, Option chosen and the Policy Year.

b) Plan Option 2: Deferred Income

The Survival Benefits are payable in arrears and shall be equal to sum of:

i) Guaranteed Income, as a percentage of Sum Assured per annum as described in Table 2 below, payable from the Premium Payment Term plus 3 years till the end of Premium Payment Term plus 12 years

And

ii) Annual Cash Bonus, if declared, as a percentage of Sum Assured, payable from the Premium Payment Term plus 3 years till end of the Policy Term. The amount of bonus will depend upon the Sum Assured, Plan Option chosen and the Policy Year.

c) Guaranteed Income:

➤ Guaranteed Income is calculated by multiplying Guaranteed Income Rate by Sum Assured

- You can opt to receive Survival Benefits (Guaranteed Income, if any and Annual Cash Bonus, if declared in half-yearly, quarterly or monthly frequency instead of annually. The Survival Benefits shall be payable as follows:
 - a) Yearly - 100% (of Survival Benefits payable annually) shall be payable on annual Policy Anniversary in arrears
 - b) Half yearly – 49% (of Survival Benefits payable annually) shall be payable on half yearly Policy Anniversary in arrears
 - c) Quarterly – 24.25% (of Survival Benefits payable annually) shall be payable on quarterly Policy Anniversary in arrears
 - d) Monthly – 8% (of Survival Benefit payable annually) shall be payable on monthly Policy Anniversary in arrears
- Survival Benefit payment frequency chosen by You at inception of the Policy is mentioned in the Schedule under Section 3(e). You can change the Survival Benefit payment frequency anytime during the Policy Term. The revised frequency of Survival Benefit payments shall be applicable on Policy Anniversary.
- Life Assured should be alive as on due date of the Survival Benefit payout.
- Payment of Survival Benefit is subject to deduction of any outstanding dues from You under this Policy including but not limited to outstanding Policy loan, loan interest or any other dues and applicable taxes, if any.

5) Maturity Benefit

PART C

- a) If the Life Assured is alive on the Maturity Date as specified in the Schedule and if all Instalment Premiums have been received in full, the Sum Assured on Maturity as specified in the Schedule (which is equal to 2 X Sum Assured) plus Terminal Bonus, if declared, shall be paid.
- b) Payment of Maturity Benefit under Clause 5 (a) is subject to deduction of any outstanding dues from You under this Policy including but not limited to outstanding Policy loan, loan interest or any other dues and applicable taxes, if any.
- c) The Policy will terminate on payment of Maturity Benefit.

6) Premium Payment Conditions

a) Payment of Instalment Premium:

Instalment Premiums shall be payable in full on the Premium Due Dates until the expiry of the Premium Payment Term or death of the Life Assured whichever is earlier. The Instalment Premiums shall be deemed to have been paid only when they have been received at Our head office or any other office authorized by Us for that purpose and due written acknowledgment has been issued by Us against such payment.

- b) Change in Premium Payment Frequency:** We will permit any change to be made to the frequency at which the Instalment Premium is payable as recorded in the Policy Schedule. Such change will be permitted during the Premium Payment Term, is subject to minimum premium requirements and will be applicable on Policy Anniversary. There shall be no charge made for change of premium payment frequency, however relevant modal factor shall apply.

The premiums for various modes as a percentage of annual premium are given below:

- a) Half-yearly premium – 52.0% of annual premium
- b) Quarterly premium - 26.5% of annual premium
- c) Monthly premium - 8.83% of annual premium

The Company will offer waiver of modal premium loadings for Annualized Premium of Rs. 1 crore and above.

c) Deduction of Instalment Premiums from the Claim Amount:

PART C

If this Policy is In-force and the Death Benefit becomes payable in accordance with the Part C, any Instalment Premiums that becomes due till the next Policy Anniversary, shall be deducted from the Death Benefit payable under this Policy.

d) **Cessation of Payment of Instalment Premium:**

If the Life Assured dies during the Policy Term, any Instalment Premiums that would otherwise have been due on or after following the death of the Life Assured are not required to be paid to Us other than Instalment Premiums due as per Clause 6(c).

7) **Grace Period**

Any Instalment Premium which is not received in full by the Premium Due Date may be paid in full during the Grace Period of 30 days for yearly, half-yearly and quarterly premium payment frequencies and 15 days for monthly premium payment frequencies from the Premium Due Date. This Policy will remain In-force during the Grace Period. If a valid claim arises during the Grace Period, the claim shall be honoured in accordance with the provisions of Part C above after deducting the due premium. If any Instalment Premium remains unpaid at the end of the Grace Period, the policy will be subject to the non-forfeiture provisions as stipulated in Part D.

PART D

POLICY SERVICING CONDITIONS

The procedure and conditions applicable to various Policy servicing aspects pertaining to this Policy are specified in this Part D below.

Non-Forfeiture Provisions

If any Instalment Premium remains unpaid at the end of the Grace Period (Refer Part C), this Policy will be subject to the non-forfeiture provisions as stipulated below.

1. Lapse of this Policy

- a) If all due Premiums for the first (1) Policy Year has not been paid in full within the Grace Period, the Policy shall Lapse and will have no value.
- b) All the risk cover ceases while the Policy is in Lapse status. The Death Benefit shall not be payable if the Life Assured dies after this Policy has Lapsed and before it has been Revived in accordance with Part D of this Policy.
- c) Survival Benefit payable, if any, shall stop once the Policy is in Lapse status.
- d) This Lapsed Policy may be revived by You within the Revival Period in accordance with Part D of this Policy.
- e) If this Lapsed Policy is not revived within the Revival Period, no Lapse value /benefit shall be payable on the date of expiry of Revival Period, and this Policy will terminate.

2. Conversion of this Policy to a Reduced Paid-up Policy

- a) If after the receipt of Instalment Premiums for the first one (1) or more Policy Years in full, any subsequent Instalment Premium remains unpaid upon the expiry of the Grace Period, this Policy will be converted into a Reduced Paid Up Policy.
- b) If this Policy is converted to a Reduced Paid-Up Policy, it shall not be eligible for any future Annual Cash Bonuses, if declared, from the date of first unpaid premium
- c) Sum Assured on Death, Sum Assured on Maturity and Guaranteed Income will be reduced in proportion to the number of premiums paid to the number of premiums payable under the Policy and shall be payable in the manner set out in Part C above.
- d) The paid-up sum assured is calculated as follows:
Paid-Up Sum Assured = Sum Assured * (Number of premiums paid / Total number of premiums payable)
- e) **Paid Up Death Benefit:**

PART D

- a. On death of the Life Assured during the Policy Term while the Policy is in Reduced Paid-Up status, the reduced Death Benefit payable shall be Paid-Up Sum Assured on Death.
- b. **Paid-Up Sum Assured on Death** = (Number of premiums paid / Total number of premiums payable) * Sum Assured on Death
- f) **Paid Up Survival Benefit:**
 - a. While the Policy is in Reduced Paid-Up status, on survival of the Life Assured on Survival Benefit payment dates, the reduced Survival Benefit (i.e. Paid-Up Guaranteed Income, if any), shall be paid.

Paid-Up Guaranteed Income= (Guaranteed Income Rate p.a. for the Plan Option chosen, if any and eligible) x (Paid-Up Sum Assured)
Guaranteed Income Rate p.a. for the Plan Options is defined in section 4(c) of Part C.
 - b. No Annual Cash Bonuses, if declared, shall be payable to a Reduced Paid-Up Policy.
- g) **Paid Up Maturity Benefit:**
 - a. On survival of the Life Assured till the end of the Policy Term while the Policy is in Reduced Paid-up status, the reduced Maturity Benefit payable shall be Paid up Sum Assured on Maturity
 - b. **Paid-Up Sum Assured on Maturity** = (Number of premiums paid / Total number of premiums payable) * Sum Assured on Maturity
- h) This Reduced Paid up Policy may be revived by You within the Revival Period in accordance with Part D of this Policy or may be surrendered in accordance with Part D of this Policy.
- i) If this Reduced Paid-Up Policy is not revived within the Revival Period, the Policy shall continue to be in the Reduced Paid-Up status till the end of Policy Term.

If the Paid up Sum assured (exclusive of Guaranteed Income and Annual Cash Bonus) is less than rupees two thousand five hundred, the Policy may be terminated after expiry of revival period by paying the surrender value.

3. Surrender

- a) You may Surrender this Policy at any time before Maturity of the Policy or before death of the Life Assured during the Policy Term, whichever is earlier. Upon Surrender, you will be eligible for Surrender Value, if any, as per the provisions given under this clause.
- b) This Policy will acquire Surrender Value after the completion of first policy year provided one (1) full year premium has been received. Once this Policy has acquired a Surrender Value, this Policy

or the Reduced Paid-Up Policy may be Surrendered during the Policy Term and We will pay You the Surrender Value.

- c) The Surrender Value on this Policy shall be the Special Surrender Value or the Guaranteed Surrender Value, whichever is higher as defined below.

i) **Guaranteed Surrender Value (GSV)**

Guaranteed Surrender Value = Guaranteed Surrender Value Factor for Premium x [Total premiums paid (excluding applicable taxes, rider premium and extra premiums, if collected explicitly)] less (sum of Survival Benefits paid till date)

The Guaranteed Surrender Value Factors are provided in **Annexure IV**. The factors shown in **Annexure IV** of this Policy will be applicable once the Policy has acquired a Surrender Value.

- ii) **Special Surrender Value (SSV):** means an amount which is calculated in the following manner:

a) **For premium paying and Reduced Paid-Up Policy (i.e. other than Fully Paid-Up Policy):**

Special Surrender Value Factor for Sum Assured x (Paid-up Sum Assured)

PLUS

Special Surrender Value Factor for future Guaranteed Income x 3% x (Paid-Up Sum Assured)

Where **Paid-Up Sum Assured** = Sum Assured * (Number of premiums paid / Total number of premiums payable)

b) **For Fully Paid-Up Policy :**

Special Surrender Value Factor for Sum Assured x (Sum Assured)

PLUS

Special Surrender Value Factor for future Guaranteed Income x 3% x (Sum Assured)

PLUS

Special Surrender Value Factor for Contingent Future Annual Cash Bonus x (Contingent Future Annual Cash Bonus, if declared)

PART D

Special Surrender Value (SSV) shall be based on the Company's expectation of future financial and demographic conditions and may be reviewed annually by the Company in accordance with the applicable IRDAI regulations in this behalf..

Contingent Annual Cash Bonus, if declared, applicable for SSV shall be declared each Financial Year by the Company and will be explicitly applicable only when a Fully Paid-Up Policy is surrendered.

- d) This Policy shall automatically terminate on payment of Surrender Value and no other benefits will be paid to You under this Policy.

4. Revival

- a) If this Policy has Lapsed or has turned into a Reduced Paid-Up Policy, it may be revived within the expiry of the Revival Period or the Maturity Date, whichever is earlier, unless this Policy has been surrendered in accordance with this Part D. Revival Period is five consecutive years from the date of first unpaid premium.
- b) Revival of a Policy cannot be done once the Policy Term is over. In order to Revive this Policy, You must give Us a request for Revival along with:
- i) The Life Assured's health declaration and other evidences of continued insurability as per Our Board Approved Underwriting policy.
 - ii) Payment of all overdue Instalment Premiums in full (along with applicable taxes, if any) and interest, if any, at such a rate as may be determined by Us from time to time.
 - iii) The revival interest rate shall be determined by the Company from time to time based on current market interest rate on 10-year Government securities (G-Sec) as on 31st March every year + 2% rounded to nearest 1%. The interest rate applicable for the financial year will be declared at start of the financial year. The simple interest rate charged is 9% p.a. for FY 2024-25. 10-year G-Sec rates are as declared by FIMMDA (Fixed Income Money Market and Derivatives Association of India). However, We may decide to increase the interest charged on Revival from time to time with prior approval from IRDAI.
 - iv) We, however, reserves the right to accept on original terms, or on modified terms or decline the revival of a discontinued policy. The Policy shall be considered to be revived only when a confirmation to this effect is issued by the Company to You.

PART D

- c) In case of Revival of a lapsed Policy, all the Guaranteed Income payouts and Annual Cash Bonuses, as applicable and due while the Policy was in lapse status, shall be paid out, as a lump sum.
- d) In case of Revival of a Paid-Up Policy, all the Guaranteed Income payouts and Annual Cash Bonuses, as applicable and due while the Policy was in Paid Up status, less any Paid-Up Survival Benefits already paid while the Policy was in Paid-Up status, shall be paid out as a lump sum.
- e) This Policy will be revived in accordance with Our board approved underwriting policy.
- f) Any Revival shall only cover the loss or Insured Event which occurs after the Revival Date.

5. Loans

- a) Loan will be provided under this Policy subject to the following conditions:
 - i) If this Policy has acquired Surrender Value, loan is available under the Policy to the extent of 85% of the Surrender Value. In case of any significant increase in the interest rates, the Company may change the percentage of Surrender Value available as loan, with prior approval from IRDAI
 - ii) Interest shall accrue on Policy loan at a rate which shall be determined by Us from time to time based on current market interest rate on 10-year Government Securities (G-Sec) as on 31st March every year + 2% rounded to nearest 1%. G-Sec rates are as declared by FIMMDA (Fixed Income Money Market and Derivatives Association of India). The interest rate applicable for the Financial Year will be declared at start of the Financial Year. The current interest rate for the Financial Year 2024-25 applicable on loans is 9% per annum compounded half-yearly. 10-year G-Sec rates are as declared by FIMMDA (Fixed Income Money Market And Derivatives Association Of India). Please contact Us or Our nearest branch for information on latest interest rate on loans.
 - iii) Any change in the basis of determination of interest rate as given above for Policy loan shall be done only after prior approval of the IRDAI.
 - iv) The minimum amount of Policy loan that can be taken is Rs.10,000/-.
 - v) Any unpaid interest shall be added to the principal loan and bear interest at the prevalent rate.
 - vi) You have the option to repay the principal and accrued interest in full or any part of the loan anytime during the Policy Term.
 - vii) Any unpaid loan or interest on this Policy will be deducted from any payment or proceeds due to You under this Policy at the time of settlement.

PART D

- viii) Our claim for any outstanding loan including any outstanding interest will have priority over any other claim against the Policy.
- ix) Interest shall be payable on the next Policy Anniversary or six months before the next Policy Anniversary if earlier, after the loan date; and every six months thereafter until the loan is repaid.
- x) Whilst the Policy is in Reduced Paid-Up status, in the event of failure to pay the loan interest on the due dates, under circumstances when the loan with outstanding interest exceeds the Surrender Value, this Policy shall be terminated. This provision will not apply in the event that the Policy is in in-force status or all premiums payable under the Policy stand paid.
- xi) Until such time as the loan persists in Our books, Your Policy shall remain assigned to Us.
- xii) Policy Loan will not be extended beyond the Maturity Date.
- xiii) Under circumstances when the loan amount along with outstanding interest exceeds the Surrender Value, the Policyholder shall be intimated of the same and shall be given a period of three months to repay the outstanding dues. In the event of failure to repay by the required date, the Policy will be terminated/foreclosed. This provision will not apply in the event that the Policy is in in-force status or all premiums payable under the Policy stand paid.

6. Free Look Period

- a) You may return this Policy within 30 days of receipt of the Policy Document (whether received electronically or otherwise) if You disagree with any of the terms and conditions of the policy, by giving Us a request for cancellation of this Policy which states the reasons for Your objections. We will cancel this Policy if You have not made any claims and refund the Instalment Premium received after deducting proportionate risk premium for the period of cover, stamp duty charges and expenses incurred by Us on the medical examination of the Life Assured (if any).

If the policy is opted through Insurance Repository (IR), the computation of the said Free Look Period will be as stated below:-

- For existing e-Insurance Account: Computation of the said Free Look Period will commence from the date of delivery of the e-mail confirming the credit of the Insurance policy by the IR.
- For New e-Insurance Account: If an application for e-Insurance Account accompanies the proposal for insurance, the date of receipt of the 'welcome kit' from the IR with the credentials to log on to the eInsurance Account (eIA) or the delivery date of the email confirming the grant of access to the eIA or the delivery date of the email confirming the credit of the Insurance policy by the IR to the eIA, whichever is later shall be reckoned for the purpose of computation of the Free Look Period.

PART E

Applicable Charges, Funds & Fund Options

- 1) No charges or fees are applicable under this Policy.
- 2) This Policy is a non-linked insurance product, so no funds or fund options are available.

PART F

General Terms & Conditions

1) Fraud and Misstatement

Please note the terms of Section 45 of the Insurance Act, **1938**, as amended from time to time, which states as follows:

- (1) No policy of life insurance shall be called in question on any ground whatsoever after the expiry of three years from the date of the policy, i.e., from the date of issuance of the policy or the date of commencement of risk or the date of revival of the policy or the date of the rider to the policy, whichever is later.*
- (2) A policy of life insurance may be called in question at any time within three years from the date of issuance of the policy or the date of commencement of risk or the date of revival of the policy or the date of the rider to the policy, whichever is later, on the ground of fraud: Provided that the insurer shall have to communicate in writing to the insured or the legal representatives or nominees or Assignees of the insured the grounds and materials on which such decision is based.*

Explanation I.—For the purposes of this sub-section, the expression "fraud" means any of the following acts committed by the insured or by his agent, with intent to deceive the insurer or to induce the insurer to issue a life insurance policy:—

- (a) the suggestion, as a fact of that which is not true and which the insured does not believe to be true;*
- (b) the active concealment of a fact by the insured having knowledge or belief of the fact;*
- (c) any other act fitted to deceive; and*
- (d) any such act or omission as the law specially declares to be fraudulent.*

Explanation II.—Mere silence as to facts likely to affect the assessment of the risk by the insurer is not fraud, unless the circumstances of the case are such that regard being had to them, it is the duty of the insured or his agent keeping silence, to speak, or unless his silence is, in itself, equivalent to speak.

PART F

- (3) *Notwithstanding anything contained in sub-section(2), no insurer shall repudiate a life insurance policy on the ground of fraud if the insured can prove that the mis-statement of or suppression of a material fact was true to the best of his knowledge and belief or that there was no deliberate intention to suppress the fact or that such mis-statement of or suppression of a material fact are within the knowledge of the insurer:*

Provided that in case of fraud, the onus of disproving lies upon the beneficiaries, in case the policyholder is not alive.

Explanation.—A person who solicits and negotiates a contract of insurance shall be deemed for the purpose of the formation of the contract, to be the agent of the insurer.

- (4) *A policy of life insurance may be called in question at any time within three years from the date of issuance of the policy or the date of commencement of risk or the date of revival of the policy or the date of the rider to the policy, whichever is later, on the ground that any statement of or suppression of a fact material to the expectancy of the life of the insured was incorrectly made in the proposal or other document on the basis of which the policy was issued or revived or rider issued:*

Provided that the insurer shall have to communicate in writing to the insured or the legal representatives or nominees or Assignees of the insured the grounds and materials on which such decision to repudiate the policy of life insurance is based.

Provided further that in case of repudiation of the policy on the ground of mis-statement or suppression of a material fact, and not on the ground of fraud, the premiums collected on the policy till the date of repudiation shall be paid to the insured or the legal representatives or nominees or Assignees of the insured within a period of ninety days from the date of such repudiation.

Explanation.—For the purposes of this sub-section, the misstatement of or suppression of fact shall not be considered material unless it has a direct bearing on the risk undertaken by the insurer, the onus is on the insurer to show that had the insurer been aware of the said fact no life insurance policy would have been issued to the insured.

PART F

(5) Nothing in this section shall prevent the insurer from calling for proof of age at any time if he is entitled to do so, and no Policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof that the age of the life insured was incorrectly stated in the proposal.

2) Statement of Age

- a) This Policy is issued at the Age shown in the Schedule which is the Life Assured's declared Age as at the Policy Commencement Date. In the event the declared Age as at the Policy Commencement Date is found to be different from the actual Age on the Policy Commencement Date, without prejudice to Our other rights and remedies, including those under the Insurance Act, 1938, as amended from time to time, one of the following actions may be taken:
- i) If the Age of the Life Assured has been misstated and if the correct Age of the Life Assured makes the Life Assured ineligible for this Policy, We may offer a suitable plan as per the then existing underwriting norms. If the Life Assured does not wish to opt for the alternative plan or if it is not possible for Us to grant any other plan, then this Policy shall be cancelled and the premiums paid shall be refunded without interest, subject to deduction of stamp duty paid and the cost of medicals, if any. The Policy will terminate on the said payment.
 - ii) If the actual Age of the Life Assured is higher than the declared Age and higher Instalment Premiums should have been charged per Our board approved underwriting Policy, the benefits payable under this Policy shall be reduced to the amount that the Instalment Premiums received would have purchased at the actual Age of the Life Assured.
 - iii) If the actual Age of the Life Assured is lower than the declared Age and lower Instalment Premiums should have been charged per Our board approved underwriting Policy, We will refund any excess premiums received, without any interest.
 - iv) This clause will be as per provisions of Section 45 of the Insurance Act, as amended from time to time.

PART F

The following provisions apply only if the Life Assured is less than Age 18 on the Risk Commencement Date:

- a) The policy vests on the Life Assured on the policy anniversary coinciding with or immediately following the 18th birthday of the Life Assured.

Upon such vesting, the Policy will be deemed to be a contract between the Life Assured (also the policyholder there forth) as the owner of the policy and the Company. The erstwhile policyholder or his estate shall cease to have any right or interest therein.

- b) If You die when the Life Assured is less than Age 18:

i) No immediate benefit will be payable under this Policy, but this Policy may be continued for the remainder of the Policy Term with the appointment of the Life Assured's parents or legal guardian as the Policyholder for all purposes as per the law of the land.

ii) When the Life Assured attains the age of 18 years, the Policy shall automatically vest in the Life Assured on such Date.

iii) If this Policy has been converted to a Reduced Paid-Up Policy and a new Policyholder is not available or interested in continuing this Policy on Your death, this Policy may either remain a Reduced Paid-Up Policy for the remainder of the Policy Term or may be Surrendered in accordance with the provisions of Part D of this Policy by the Life Assured's parents or legal guardian provided that the necessary permission of the Indian courts/authorities has been obtained, if applicable.

iv) If this Policy has not been converted to a Reduced Paid-Up Policy and a new Policyholder is not available or interested in continuing this Policy on Your death, this Policy will automatically Lapse or become Reduced Paid-Up and the provisions of Part D of this Policy shall apply.

4) Claims Procedures**Payment of Death Benefits**

- a) The death of the Life Assured must be notified to Us in writing
- b) Proof of death and any appropriate documents as required by Us must be completed and furnished to Us, not later than 90 days from the date of death of the Life Assured, unless specified otherwise. However, a notification of claim received after 90 days may be accepted subject to the sole discretion

of the Company, if the claimant proves that there was delay for reason beyond the control of the claimant.

- c) The following documentation must necessarily be submitted to Us for Us to process the death claim:
- i) Original Policy Document;
 - ii) Original death certificate issued by the competent authority;
 - iii) Post mortem report / FIR, where applicable;
 - iv) Claim forms duly completed as required by Us;
 - v) Certificate from physician/hospital last attended showing cause of death wherever applicable;
 - vi) A copy of past medical records for diagnosis and treatment with complete details of Illness, wherever applicable.
 - vii) Legal evidence of title of the claimant where no valid Nomination or Assignment under this Policy exists or in cases where the title is in dispute;
 - viii) Proof of Age, if the Age has not been admitted under the Policy earlier.
 - ix) Self-attested copy of the PAN Card or Form 60 of Claimant
 - x) KYC documents including photograph of the Claimant
 - xi) Bank details with supporting documents of Claimant
- d) We may, however, call for additional documents, if found necessary, in support of the claim.

Payment of Maturity Benefits

- a) The following documents need to be submitted to Us for payment of Maturity Benefits:
- i) Self-attested copy of the PAN Card or Form 60 and KYC documents if not submitted already
 - ii) Bank details with supporting documents such as cancelled cheque or bank passbook
 - iii) Original Policy bond, unless it is waived in the case of electronic policies through insurance repositories or for other reasons as per internal Policy of the Company
 - iv) Such other documents as may be required under applicable laws notified from time to time.

5) Termination of the Policy

This Policy will cease immediately and automatically on the happening of the earliest of any of the following and will constitute a valid discharge of Our liability under the Policy:

- a) on the date of payment of the entire Death Benefit upon the death of the Life Assured;

- b) on the date of payment of the amount as per suicide clause in accordance with Clause 7(a) of this Part F of this Policy;
- c) on the date of payment of Maturity Benefit
- d) on the date of payment of Surrender Value of this Policy;
- e) on the date of receipt of Free Look request in accordance with Part D of this Policy;
- f) on the expiry of the Revival Period provided We have not received the due unpaid premiums along with interest from You till the expiry of such period and this Policy is not under the Reduced Paid-Up status.
- g) foreclosure under circumstances when the loan with outstanding interest exceeds the Surrender Value.

6) The Policyholder's Rights

- a) You are the Policyholder of this Policy. Unless provided otherwise in the terms of this Policy or through the provisions of applicable Indian law, only You can, during the lifetime of the Life Assured, exercise all rights, privileges and options provided under this Policy subject to any Nominee's vested interest or any Assignee's rights, if any.
- b) This Policy describes the options available to You upon non-payment of due premium as specified in Part D of this Policy. In no event, Company is under any obligation to send any separate notice(s) to You for reiteration of these options or payment of Instalment Premium. You are solely responsible to pay Instalment Premium on time as specified in this Policy Document.

7) Suicide Exclusion:

Annexure II

Section 38 - Assignment or Transfer of Insurance Policies Assignment or transfer of a policy should be in accordance with Section 38 of the Insurance Act, 1938 as amended by Insurance Laws (Amendment) Act, 2015 dated 23.03.2015. The extant provisions in this regard are as follows:

- (1) This policy may be transferred/assigned, wholly or in part, with or without consideration.
- (2) An Assignment may be effected in a policy by an endorsement upon the policy itself or by a separate instrument under notice to the Insurer.
- (3) The instrument of Assignment should indicate the fact of transfer or Assignment and the reasons for the Assignment or transfer, antecedents of the Assignee and terms on which Assignment is made.
- (4) The Assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness.
- (5) The transfer or Assignment shall not be operative as against an insurer until a notice in writing of the transfer or Assignment and either the said endorsement or instrument itself or copy there of certified to be correct by both transferor and transferee or their duly authorised agents have been delivered to the insurer.
- (6) Fee to be paid for Assignment or transfer can be specified by the Authority through Regulations.
- (7) On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the insurer of duly receiving the notice.
- (8) If the insurer maintains one or more places of business, such notices shall be delivered only at the place where the policy is being serviced.
- (9) The insurer may accept or decline to act upon any transfer or Assignment or endorsement, if it has sufficient reasons to believe that it is (a) not bonafide or (b) not in the interest of the policyholder or (c) not in public interest or (d) is for the purpose of trading of the insurance policy.
- (10) Before refusing to act upon endorsement, the Insurer should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of policyholder giving a notice of transfer or Assignment.
- (11) In case of refusal to act upon the endorsement by the Insurer, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Insurer.
- (12) The priority of claims of persons interested in an insurance policy would depend on the date on which the notices of Assignment or transfer is delivered to the insurer; where there are more than one instruments of transfer or Assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to Authority.
- (13) Every Assignment or transfer shall be deemed to be absolute Assignment or transfer and the Assignee or transferee shall be deemed to be absolute Assignee or transferee, except a. where Assignment or transfer is subject to terms and conditions of transfer or Assignment OR
b. where the transfer or Assignment is made upon condition that
 - i. the proceeds under the policy shall become payable to policyholder or nominee(s) in the event of Assignee or transferee dying before the insured OR
 - ii. the insured surviving the term of the policy

Such conditional Assignee will not be entitled to obtain a loan on policy or surrender the policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.

(14) In other cases, the insurer shall, subject to terms and conditions of Assignment, recognize the transferee or Assignee named in the notice as the absolute transferee or Assignee and such person

a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or Assignment and

- b. may institute any proceedings in relation to the policy
- c. obtain loan under the policy or surrender the policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings

(15) Any rights and remedies of an Assignee or transferee of a life insurance policy under an Assignment or transfer effected before commencement of the Insurance Laws (Amendment) Act, 2015 shall not be affected by this section.

Annexure III

Nomination of a life insurance Policy is as below in accordance with Section 39 of the Insurance Act, 1938 as amended by Insurance Laws (Amendment) Act, 2015 dated 23.03.2015. The extant provisions in this regard are as follows:

- 1) The policyholder of a life insurance on his own life may nominate a person or persons to whom money secured by the policy shall be paid in the event of his death.
- 2) Where the nominee is a minor, the policyholder may appoint any person to receive the money secured by the policy in the event of policyholder's death during the minority of the nominee. The manner of appointment to be laid down by the insurer.
- 3) Nomination can be made at any time before the maturity of the policy.
- 4) Nomination may be incorporated in the text of the policy itself or may be endorsed on the policy communicated to the insurer and can be registered by the insurer in the records relating to the policy.
- 5) Nomination can be cancelled or changed at any time before policy matures, by an endorsement or a further endorsement or a will as the case may be.
- 6) A notice in writing of Change or Cancellation of Nomination must be delivered to the insurer for the insurer to be liable to such nominee. Otherwise, insurer will not be liable if a bonafide payment is made to the person named in the text of the policy or in the registered records of the insurer.
- 7) Fee to be paid to the insurer for registering change or cancellation of a Nomination can be specified by the Authority through Regulations.
- 8) On receipt of notice with fee, the insurer should grant a written acknowledgement to the policyholder of having registered a Nomination or cancellation or change thereof.
- 9) A transfer or Assignment made in accordance with Section 38 shall automatically cancel the Nomination except in case of Assignment to the insurer or other transferee or Assignee for purpose of loan or against security or its reAssignment after repayment. In such case, the Nomination will not get cancelled to the extent of insurer's or transferee's or Assignee's interest in the policy. The Nomination will get revived on repayment of the loan.
- 10) The right of any creditor to be paid out of the proceeds of any policy of life insurance shall not be affected by the Nomination.
- 11) In case of Nomination by policyholder whose life is insured, if the nominees die before the policyholder, the proceeds are payable to policyholder or his heirs or legal representatives or holder of succession certificate.
- 12) In case nominee(s) survive the person whose life is insured, the amount secured by the policy shall be paid to such survivor(s).
- 13) Where the policyholder whose life is insured nominates his (a) parents or (b) spouse or (c) children or (d) spouse and children (e) or any of them; the nominees are beneficially entitled to the amount payable by the insurer to the policyholder unless it is proved that policyholder could not have conferred such beneficial title on the nominee having regard to the nature of his title.

14) If nominee(s) die after the policyholder but before his share of the amount secured under the policy is paid, the share of the expired nominee(s) shall be payable to the heirs or legal representative of the nominee or holder of succession certificate of such nominee(s).

15) The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance policies maturing for payment after the commencement of Insurance Laws (Amendment) Act, 2015 (i.e. 23.03.2015).

16) If policyholder dies after maturity but the proceeds and benefit of the policy has not been paid to him because of his death, his nominee(s) shall be entitled to the proceeds and benefit of the policy.

17) The provisions of Section 39 are not applicable to any life insurance policy to which Section 6 of Married Women's Property Act, 1874 applies or has at any time applied except where before or Insurance Laws (Amendment) Act, 2015, a Nomination is made in favour of spouse or children or spouse and children whether or not on the face of the policy it is mentioned that it is made under Section 39. Where Nomination is intended to be made to spouse or children or spouse and children under Section 6 of MWP Act, it should be specifically mentioned on the policy. In such a case only, the provisions of Section 39 will not apply.
